G.S.R. 2. After the first proviso, the following proviso shall be inserted with effect from the 4<sup>th</sup> day of August, 2018 namely:-  
“Provided further that nothing contained in entries against serial numbers 14,21B, 21C, 21D, 24A, 24B, 26A, 32A,177, 177A, 249A, 250A, 371A, 371B, 376A, and 377A of the said Table, shall apply to goods originating in the United States of America”.
3. Save as otherwise provided, this notification shall come into force on the date of its issue by the Central Government for publication in the Official Gazette.
