Dear chief Commissiones / Directors general,

As you are aware the four GST laws have received the assent of the President of India on 12th April, 2017. As on date, five States have already passed the SGST law and the others are expected to do so next month. Similarly, 14 Rules have been put in the public domain and are available on the departmental website with some more to come.

- 2. While officers and staff of CBEC have been receiving training from NACEN, there is a need for updating of knowledge on the legislative and procedural aspects of GST.
- 3. Since the new regime is all set for roll out on 1st July, 2017, very little time is left to equip our officers with the requisite updated knowledge on GST. In this context, the Chief Commissioner, Ahmadabad Zone, has initiated (copy enclosed) an in-house system of updating and dissemination of information on GST to all officers and staff. Under this initiative, the Master Trainers and senior level officers of DC/JC rank posted in the zone are being utilized to impart training at the local level. These trainers have been directed to prepare presentations covering specific provisions of GST laws, corresponding Rules and the forms wherever notified. These presentations will be made before other officers of the zone and will also be shared with DG, NACEN for circulation.
- 4. I would suggest that all of you follow a similar practice of peer training to ensure that officers and staff at all levels are fully equipped with the required knowledge to enable handholding of the assessees in every respect.

Madam,

It is to report that 1310 officers have already been trained in respect of the Model GST law. Thus all the officers working in Central Excise & Service Tax Commissionerates have been trained. The training for the Customs officers shall also be completed shortly.

- 2. This is to bring to your kind notice, that in the meanwhile number of important changes have taken place in the Model GST law. The Draft of GST rules have also been put in public domain by the Government. Some of these have been approved by the GST Council as well.
- 3. It is felt that there is necessasity to update knowledge of officers at various levels in such a constantly changing environment. It may take some time for the NACEN to prepare standard training materials and disseminate to the field formations. As the government has decided to implement the GST from 1st of July, 2017, in Ahmedabad Central Excise Zone it has been decided to utilise the Master Trainers and senior level officers of DC/JC rank to impart training in this regard. They are being directed to prepare presentations covering provisions of relevant Model GST law, corresponding rules and the forms wherever notified.
- 4. The presentation will be made before the senior level officers including Chief Commissioner in this week itself. The Presentation prepared will be shared with DG, NACEN as well. This is for your kind information please.
