Sub: Preparation of panel for appointment of Intelligence Officer, on deputation basis in the Directorate General of GST Intelligence, Raipur Zonal Unit.

The Directorate General of GST Intelligence, Raipur Zonal Unit is in the process of drawing a panel of willing and suitable candidates for filling up the existing/anticipated vacancies at Zonal Unit, Raipur in the following grade of Intelligence Officer on deputation basis. The vacancies are to be filled up by appointing suitable officers of equivalent grade in Customs and CGST/Central Excise.

2. The selected officers, while working in the Directorate General will be entitled for deputation allowance as admissible. Normally, the deputation is for a period of three years for IO, which is extendable by another two years, subject to the willingness of the officers, his/her performance, and the concurrence of his/her parent Commissionerate and approval of the competent authority. It may be made clear to the willing officers that the option once exercised would be

final and in the event of selection, they will not be allowed to withdraw the same. The Officers may exercise their willingness through proper channel. Experience in Preventive/Anti-evasion is preferable.

While forwarding the names of the willing officers, the following information may also please be sent for evaluation by this Directorate.
- (a) Complete bio-data and willingness of the officer along with history of postings;
- (b) ACR/APAR gradings for the last five years duly verified and attested by the Additional/Joint Commissioner (P&V);
- (c) Vigilance Clearance Certificate;
- (d) "No Objection Certificate" from the Cadre Controlling Authority to relieve the officer in the event of his/her selection.
- 4. The above information/details may please be arranged to be furnished to this office preferably by **30.06.2018**.
