Based on the inputs received from various sections, following is the compilation of the important developments for the week –05.02.18 to 09.02.18.

1. Administrative Changes:-

- Order regarding placing services of 02 Group ‘A’ officers with the Government of Tamil Nadu namely Ms. B. Yamuna Devi, Additional Commissioner and Nalina Sofia T., deputy Commissioner has been issued vide Office Order No. 18/2018 dated 06.02.2018.
- Order regarding assigning of additional charge to handle queries related to GST on Twitter/Email in respect of 08 IRS Group ‘A’ officers has been issued vide Office Order No. 19/2018 dated 07.02.2018.
- Order regarding ad-hoc promotion to the grade of Chief Commissioner of Customs, GST & Central Excise in respect of Shri K. Raghu N. Chary, IRS has been issued vide Office Order No. 20/2018 dated 07.02.2018.
- Order regarding transfer/posting in the grade of Commissioner of Customs, GST and Central Excise in respect of SAhri S. Thirunavukkarasu, Commissioner has been issued vide Office Order No. 21/2018 dated 07.02.2018.
- Order regarding extension of loan period for further 06 months in respect of Shri Y.P. Singh, IRS has been issued vide Office Order No. 22/2018.
- Order regarding extension of loan period for further 03 months in respect of Anuj Gogia, IRS has been issued vide Office Order No. 23/2018 dated 08.02.2018.
- Order regarding empanelment/promotion of Shri J.S. Chandrasekhar, IRS in the grade of Joint Commissioner of Customs, GST and Central Excise has been issued vide Office Order No. 24/2018 dated 09.02.2018.

2. Legislative Changes:-

- Notification No. 24/2018-Cus, dt. 06-02-2018 has been issued to increase import duty on all types of sugar under tariff head 1701, [Raw sugar, Refined or White sugar, Raw sugar if imported by bulk consumer] from the present 50% to 100% (Tariff rate) with immediate effect and without an end date.
- Notification No. 25/2018-Cus, dt. 06-02-2018 has been issued to increase BCD tariff rate on Chana (Chickpeas), [Tariff item 0713 20 0] from 30% to 40% by invoking section 8A (1) of the Customs Tariff Act, 1975 and accordingly, the effective rate of BCD on Chana (Chickpeas), will also be 40%., 2017.
