- Deputation of IRS(C&CE) officers with the World Customs Organization: Order regarding extension of deputation period in respect of Shri Pashupati Nath Pandey, IRS(C&CE) officer with the World Customs Organization, has been issued vide Office Order No. 175/2018 dated 12.12.2018.
- Deputation of IRS(C&CE) officers with the Department of Revenue: Order regarding placing the services of 02 (two) IRS(C&CE) officers with the Department of Revenue on deputation basis, has been issued vide Office Order No. 176/2018 dated 13.12.2018.

- Notification No.80/2018-Cus, dated 15.12.2018 issued for seeking to further postpone the implementation of increased customs duty on specified imports originating in USA from 17th December, 2018 to 31st January, 2019.
