Subject: -Weekly Report in respect of important developments in CBEC for the week –28.08.17 to 01.09.17 reg.

Based on the inputs received from various sections, following is the compilation of the important developments for the week –28.08.17 to 01.09.17.

1. Administrative Changes: -

- Order regarding Posting of Shri Shaukat Ali, IRS (C&CE: 2008), Joint Commissioner, Meerut Zone, to Directorate of International Customs (DIC) on loan basis has been issued vide Office Order No.143/2017 dated 28.08.2017.
- Order regarding appointment of Shri Vaibhav Bhatnagar, Assistant Commissioner, Noida-I, GST & Central Excise as OSD (Drawback), in CBEC has been issued vide Office Order No.144/2017 dated 28.08.2017.
- Order regarding promotion of Shri Narender Kumar Kaushik, Superintendent of Excise (Retd.) to the grade of Assistant Commissioner on purely ad-hoc basis, notionally with effect from 22.10.2014 has been issued vide Office Order No.145/2017 dated 29.08.2017.
- Order regarding Promotion/Posting of 4 IRS (C&CE) officers to the grade of Pr. CC/Pr. DG has been issued vide Office Order No.146/2017 dated 30.08.2017.
- Order regarding allocation of the Charge of Member (Customs) to Shri Pranab Kumar Das has been issued vide Office Order No.147/2017 dated 30.08.2017.
- Order regarding posting of 2 IRS(C&CE) officers as OSD in Judicial Wing of CBEC on loan basis has been issued vide Office Order No.148/2017 dated 31.08.2017.
- Order regarding assigning the additional charge in the grade of CC/DG, GST & CX of the 3 IRS (C&CE) officers has been issued vide Office Order No.149/2017 dated 31.08.2017.

2. Legislative Changes: -

- Notification No.41/2017-Cus (ADD) dated 29.08.2017 issued to continue anti-dumping inforce concerning imports of “Metronidazole” originating in or exported from China PR.
- Notification No.42/2017-Cus (ADD) dated 30.08.2017 issued to levy definitive anti-dumping duty, on Castings for Wind Operated Electricity Generators originating in or exported from China PR for a period of five years (unless revoked, superseded or amended earlier).
- Notification No.43/2017-Cus (ADD) dated 30.08.2017 issued to impose anti-dumping duty on “Styrene Butadiene Rubber (SBR)”, originating in or exported from European Union, Korea RP or Thailand.
